Meeting No-03/ 2021-22 Dated- 31.03.2022

The Governing Body meeting of Priyadarshini Indira Degree College, Junagarh was held on 31st March 2022 at 11.00 AM in the Staff Common Room of the college under the Chairmanship of Shri Pawan Sachin Kumar, IAS, Sub-Collector, Dharamgarh-cum-President, Governing Body of Priyadarshini Indira Degree College, Junagarh. In the meeting the following proposals were discussed and unanimously approved.

Resolution No- 01.

Principal proposed for alienation of Ac. 5.00 dc. Govt. Land in favour of Department of Higher Education, Govt. of Odisha marfat Principal, Priyadarshini Indira Degree College, Junagarh for construction of Academic Building under OHEPEE (World Bank Fund), Govt. of Odisha before the committee. Sub-Collector, Dharamgarh assured in the meeting for expedite the process of alienation of land proposal.

Resolution No- 02.

Principal proposed in the meeting for advanced possession of Govt. land in favour of Department of Higher Education, Govt. of Odisha marfat Principal, Priyadarshini Indira Degree College, Junagarh from Tahasildar, Junagarh for constitution of academic building under OHEPEE fund. Sub-Collector, Dharamgarh also advised to Principal for construction of academic building with the Executive Agency as well as Contractor of the project under the OHEPEE program.

Resolution No- 03.

Principal presented the application given by Sri Jyoti Ranjan Patra, Asst. Librarian, Priyadarshini Indira Mahavidyalaya, Junagarh for recommend his name to Director, Higher Education, Odisha, Bhubaneswar for Grant-in-Aid Order-2014. In the meeting, appointment of Sri Praveen Kumar Panda, Asst. Librarian and Sri Jyoti Ranjan Patra, Asst. Librarian, Priyadarshini Indira Mahavidyalaya, Junagarh was discussed. But, as per the instruction of Deputy Director, DHE Letter No- 14693/HE Date- 23.03.2021, Sri Praveen Kumar Panda failed to submit his equivalence certificate with regard to Diploma in Library Management Certificate, New Delhi for his post approval. The next Asst. Librarian Sri Jyoti Ranjan Patra has all such certificates for approval of Grant-in-Aid Order-2014 in his favour. Hence, in the meeting Sub-Collector, Dharamgarh advised to Principal for recommend

the name of Sri Jyoti Ranjan Patra, Asst. Librarian for the approval of his post at the D.H.E., Odisha level.

Resolution No- 04.

In the meeting, considering the duties / workload of Sri Amulya Kumar Sahoo, Data Entry Operator, Priyadarshini Indira Mahavidyalaya, Junagarh raised his pay from Rs. 12,000/- to Rs. 14,000/- with effect from 1st January 2022 and his annual increment of Rs. 600/- (Rupees Six Hundred only) will be applicable from 1st January 2023. The above salary hike and annual increment is unanimously approved in the meeting.

Resolution No- 05.

Regarding deposit of E.P.F. contribution in favour of Teaching and Non-Teaching staff coming under Block Grant-2009 converted to G.I.A. 2017 was deliberately discussed in the meeting. Principal presented the matter before the Sub-Collector, Dharamgarh about financial problem with regard to deposit of E.P.F. contribution under employees head. Simultaneously the Teaching and Non-Teaching staff are not agreed to contribute employee's share from 1st January 2018. In the meeting Sub-Collector, Dharamgarh also advice to follow the Govt. guidelines for deposit of EPF contribution from time to time and sought for clarification from competent authority.

Resolution No- 06.

In the meeting, Principal appraised about the existing condition of classroom of Old campus as well as New campus building. A sum of Rs. 2 Lakhs was sanctioned from Zilla Parishad Grant for the year- 2021-22 for change of AC Sheet in the Old Campus. Sub-Collector, Dharamgarh advised to Principal to execute the work as per approved Action Plan. As per feasibility of the College Development fund the Old campus as well as New campus class room may be remodel as per the need of the students and teachers.

Resolution No- 07.

Constitution of Governing Body of Priyadarshini Indira H.S. School, Junagarh will constitute as per Govt. guidelines. Sub-Collector, Dharamgarh-cum-President, Governing Body advised to re-constitute the Governing Body as per new guidelines of the Govt.
